## INTRODUCTION

GEOSPLIT LLC respects the privacy of our users. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you visit our Registration Form

## COLLECTION OF YOUR INFORMATION

We may collect information about you in a variety of ways. The information we may collect on the Registration Form includes:

### Personal Data

## **TRACKING TECHNOLOGIES**

### **Cookies and Web Beacons**
